## ESTANCIA FFA Code of Conduct 2024-2025

As a member of the Estancia FFA Chapter, I promise to abide by all of the following rules. I understand that I may be sent home at the sole discretion of my advisor, at my own or at my parent's expense, for any infraction of these rules and I agree to pay for any damages caused by my actions.

The following conduct policy is to be followed on all day and/or overnight activities:

- 1. Adhere to proper dress code (as written in the handbook).
  - a. Official Dress Guidelines
  - b. Official Dress for an FFA member includes:
  - c. An official FFA jacket zipped to the top.
  - d. Black slacks and black socks/nylons or black skirt and black nylons.
  - *e.* White collared blouse or white collared shirt.
  - f. Official FFA tie or official FFA scarf.
  - g. Black dress shoes with closed heel and toe.
    Note: Official garb of recognized religions may be worn with Official Dress. Also, appropriate personal protective equipment may be used with Official Dress.
- 2. Travel only on school provided transportation, unless special arrangements have been made with school administration and the proper paperwork has been completed and approved by school administration and advisors.
- 3. Comply, throughout the trip, with any and all instructions directed by advisor, chaperone or staff member.
- 4. Attend mandatory activities and meal functions.
- 5. Refrain at all times from the possession and consumption of illegal drugs, alcohol, and/or tobacco.
- 6. Sleep in my assigned room and not entertain members of the opposite sex in my room unless an adult chaperone is present.
- 7. Adhere to all established curfews and meeting times.
- 8. Follow the FFA Code of Ethics attached.
- 9. Follow all rules/regulations of their selected CDE. The use of any electronic device, such as cell phone and/or iPad, is prohibited during competition. Any student disqualified from an event for this reason will be removed from the team.
- 10. Refrain from the use of inappropriate language and/or gestures.
- 11. Maintain eligibility requirements of the school, as well as the NMAA. All students must be eligible at the end of the 2<sup>nd</sup> and 3<sup>rd</sup> nine weeks to attend state competition.
- 12. Only qualified teams will compete in state judging and state convention. No individuals will be allowed to judge at state. Individuals are strongly urged to judge more than one event but no more then two events.
- 13. Must be present at all scheduled practices in order to compete in any events.
- 14. Must give prior notice to missing any meet, not showing the morning of competition is unacceptable and will result in dismissal from the team.
- 15. Conduct myself in such a manner as to bring pride to my family, my school, my community, and myself.

16. I will participate in all fundraisers. I understand that there will be a quota set by Mr. Metzger and Ms. Lesley and I will meet or exceed the quota set in order to attend any CDE's.
